

## W.E. MILLS LANDING & MARINA (VVP) LICENSE FOR SPECIAL EVENTS 151 PROMENADE DRIVE

## 1. Preamble

The W.E. Mills Landing & Marina is owned, operated and maintained by the Nanaimo Port Authority, a body corporate pursuant to the Canada Marine Act.

## 2. Use for Special Events

2.9 Rental fee in the amount of

From time to time the Nanaimo Port Authority will allow the W.E. Mills Landing & Marina to be used for special events provided that the following guidelines are adhered to.

- 2.1 The access road to the pier is to be kept clear of vehicular traffic at all times during the event unless written permission is obtained from the Vice President, Real Estate or the Harbour Master or designate.
- 2.2 The circle directly in front of the pier gate is to be kept clear of vehicular traffic other than that specified by the Vice President, Real Estate or Harbour Master or designate.
- 2.3 The organization/person responsible for the event ("Licensee") will be held responsible for any damage incurred to the pier or access road to the pier, including adjacent areas during the event.
- 2.4 The Licensee will be required to provide its own security for the event if this is deemed necessary by the Authority.
- 2.5 The Licensee of the event is to ensure that the public or members of the event organization do not encroach on the property of the Cameron Island residents.
- 2.6 A member of the event organization shall be appointed as a contact person to deal with any complaints received.
- 2.7 At the conclusion of the event the pier and road access to the pier are to be returned to the state they were found.
- 2.8 A copy of a Certificate of Insurance is to be forwarded to the Nanaimo Port Authority with a minimum \$3,000,000 public general liability coverage for the event and must include a cross liability clause and personal injury coverage. The certificate must identify the Nanaimo Port Authority, its employees and its agents as additional named insured with respect to the event.
